Dear Stall Holder

MARKET CLOSED – SUNDAY 30 MAY

The Market will be CLOSED Sunday, 30th May, consistent Government Lockdown. Hopefully the market will reopen 6th June, BUT when we reopen you must comply with the Government Covid directions & the Market COVIDSafe Plan. Please use the lock down period to review your business activity and ensure you comply with the Plan.

1. You must comply with all provisions of the Rotary OCH “COVIDSafe Plan” for the operation of The Market. A copy of the plan is available at;

In summary you;

- Must have a table or barrier between your serving area and the general public of sufficient width to encourage a 1.5 metre distance between staff and the public.
 - Must have on display suitable signage to encourage safe activity in the Covid19 environment, including 1.5 metres spacing between each person, when moving or queuing in the Trader’s area.
 - Must have on each table a hand sanitiser dispenser with alcoholic sanitiser for use by staff and customers.
 - Must clean and sanitize common contact surfaces using a disinfectant to help to reduce the spread of infection.
 - Must have your own rubbish container and take away with you at the end of the market, all of your rubbish and any public rubbish caused as a consequence of your activity.
 - Must comply with the appropriate food handling regulations, if you handle or sell food.
 - Must keep accurate records of all personnel working at the Market each Sunday, **including contact details for accurate contact tracing purposes.**
 - Must familiarise yourself with all COVIDSafe regulations that apply to business activity.
2. Carrying a Face Mask is Compulsory & **Wearing it in the Market is Strongly recommended.**
3. **Having accurate records to enable contract tracing is important.**
4. From Friday 28 May: It will be mandatory for customer-facing industries that require checking-in to use the free [Victorian Government QR Code Service](#).

Customer-facing venues where you are not required to, **but are recommended to check-in via the free [Victorian Government QR Code Service](#)**, include: **Markets or market stalls.**
