## MARKET UPDATE - CLOSED 25th JULY

The Market remains closed on 25<sup>th</sup> July due to Covid lockdown restrictions – hopefully we can open 1<sup>st</sup> August, Covid restrictions permitting. Tickets purchased for 18<sup>th</sup> July still valid. In this lockdown period we ask you to consider the following issues in preparation for the Market reopening.

**QR Code Tracing** – In the current Covid situation it is essential the Market complies with all QR Code Tracing requirements. Please have the Market QR code on display & encourage staff & public to use it. Also comply with the other requirements of the Covid SAFE Plan.

**Market Renumbering** – Traders present on 11<sup>th</sup> July received a package of information, including Newsletter 13 about the renumbering of the Market which has now occurred but this **DOES NOT change the location of your trading site.** 

Updated "Terms & Conditions for Operating Stall Sites" now apply in conjunction with new Ticket wording. It also includes information about Rotary's support for the Community. If you have not received the information package, it will be given to you next time you purchase a Market ticket.

**Rubbish, waste management –** We have received a complaint from Council about rubbish & goods being left in the carpark after the Market.

Traders are reminded that; Your allocated site and surrounding area must be left clean at the conclusion of the Market. All rubbish & unsold goods must be taken away & any spillage or waste left by the public, as a consequence of your activity must be removed. Do not dispose of rubbish into shop bins.
