### **NO MARKET – AUSTRALIA DAY 26<sup>th</sup> January**

Consistent with our policy of not running the Market on Public Holidays the market will **NOT OPERATE on 26<sup>th</sup> January**. All other Sundays in December / January normal operations.

### **MARKET TERMS & CONDITIONS**

We remind you that the Rules for the operation of the Market are set out in the Terms & Conditions (Now Version 3) February 2024 & the weekly Ticket.

Last week we had Monash Council Health & Safety Offices in the Market checking all traders selling food. We can expect other Council Officers in the Market in the near future checking Market & Trader compliance with our Market Licence.

**We specifically draw your attention to the following rules;**

**Set up;** 6am to 8am (Do not commence setting up before 6AM)  
**Trading;** 8am to 1pm (The licence limits the trading hours to this time frame)

#### **Vehicle**

**Movement;** In the interest of Public Safety - No vehicle movement between 8AM & 1 PM  
In special circumstances, vehicle movement between 12 Noon & 1 PM may be approved and escorted by a Rotarian. Speed limit 5KPH (walking pace)

**Pack up;** 1pm to 2pm Please leave your site clean, no rubbish to be left in the carpark.  
**Exit:** By 2PM, via Hanover St or the middle aisle (gate 3) onto Oxford St. Remember **5 KPH**.

**Stall Space;** Traders must operate within the confines of the stall space/s purchased.

**Pre booking;** Sites will NOT be reserved unless paid for in advance.  
**Do not enter the Market (set up) unless you have paid for & received a Ticket.**

### **Thank you in advance for your compliance and support of OUR Market.**

Non compliance with all Terms & Conditions may result in a written warning & continued noncompliance – suspension of Market access.
