Covid19 Regulations

When we do reopen, Rotary & Traders will all have to operate in accordance with a Market “COVIDSafe Plan” which is currently being finalised. Monash City Council Requirements

We are pleased to advise that we are about to finalise negotiations with Monash City Council for a Licence to operate the Market for the next five years with an option of a further five years – **providing long term certainty for the Market & Stall holders.**

However, the Licence will impose new, but reasonable, obligations for our Rotary Club and all Traders. Full details will set out in a “Terms & Conditions for Operating Stall Sites” document which will be copied to all Traders and explained before we ask you to sign it.
