SUCCESSFUL REOPENING DAY

Thank you to all Traders who participated in the successful reopening of the Market on 22nd November, and have already committed to next Sunday. In the lead up to reopening Rotary distributed 7,000 flyers, promoting the Market and our Rotary support and activity within the Community. This and new signage ensures a strong community attendance.

A NEW BEGINNING

There have been changes since the shutdown – this is a NEW MARKET, with NEW arrangements including:

- New Street Signage
- New and comprehensive Monash City Council Licence Requirements. A Licence to operate the Market for the next five years with an option of a further five years – providing long term certainty for the Market & Stall holders. However, the Licence imposes new, but not unreasonable, obligations for our Rotary Club and all Traders – as set out in a “Terms & Conditions for Operating Stall Sites” document. All Traders, are required to comply with these conditions and sign an Acceptance Undertaking. We acknowledge the support of Monash City Council.
- New Market COVIDSafe PLAN – in accordance with Government public health direction requirements – which all Traders & Rotary volunteers must comply with.
NOTE: All Traders & Staff & Rotary Volunteers will be required to wear masks until further notice from Rotary who will also be auditing Trader compliance with the COVIDSafe Plan each week. (The Audit Checklist is on the website).
- New mandatory Insurance cover requirements for Rotary & All Traders. (Traders having difficulty complying with this requirement, should discuss their situation with Market Management this coming Sunday.)
- New Trader payment requirements via EFTPOS
- New Market Promotion & Marketing and communication with Traders via our Website.

All these changes impose new obligations on Rotary & ALL Traders, **BUT they provide the opportunity for a stronger & better Market into the future.**
