Dear Market Traders

Last Sunday was an excellent Market Day. Hopefully the good weather will continue for the last two Market days of 2020. We thank all Traders who are complying with the NEW Market conditions. BUT a significant number are not accepting that compliance with the NEW MARKET TERMS & CONDITIONS is a mandatory requirement.

So, we again emphasise the following key points. PLEASE MAKE A SPECIAL EFFORT TO COMPLY

- **SITE ACCESS – COUNCIL CONDITION - NO ONE IS PERMITTED TO SET UP BEFORE 6 AM**  
**Failure to comply may result in you losing your spot**
- **COVID PLAN** - You must comply with the Market COVIDSafe PLAN (**NOTE: All Traders & Staff & Rotary Volunteers must continue to wear masks**). Rotary will be auditing compliance.
- **INSURANCE** – The Market & All Traders **MUST** have Insurance cover. Rotary has purchased PROVISIONAL Insurance for all Traders who have not /cannot meet this requirement. The cost of insurance will be incorporated in the new ticket pricing (to be announced) effective from 7/2/2021. **In the interim, Traders without Insurance will be charged an Insurance Surcharge of \$5.00 per STALLHOLDER per market for the Markets from 3/1/2021 to 31/1/2021.**
- **RUBBISH**- Sites must be left clean – take all of your rubbish away.
- **VEHICLES** - Vehicle movement throughout the Market is prohibited between 8 AM & 1 PM. Early Vehicle departure, supervised by a Rotary Volunteer, can be arranged at the Rotary Caravan.
- **STALL REALLOCATIONS** - Recent stall reallocations are now permanent. Other changes will occur in future to better structure the Market.
- **TREES GARDENS & FENCES** –DO NOT attach anything to trees or fences or in gardens.
- **PAYMENT** – preferred payment method to Rotary is via EFTPOS.
- **MARKET TERMS & CONDITIONS** - Acceptance Undertakings must be completed, signed & returned to Rotary as an URGENT priority.
