Thank you for your continued support of OUR MARKET, with Spring in the air, we can expect busy markets in the months ahead.

MARKET LEASE EXTENSION

We are pleased to announce that we have negotiated an extension of **our Market** lease with Monash Council to **31st October 2030**. All of the Lease Terms & Conditions which are reflected in our Market Terms & Conditions remain in place.

MARKET TERMS & CONDITIONS

We remind you that you must accept the Terms & Conditions every time you make a booking, & comply with them every Sunday you operate in our Market. The following are key requirements;

Set up; 6am to 8am (not before)

Trading; 8am to 1pm

Vehicle Movement; In the interest of Public Safety - No vehicle movement between 8AM & 1 PM

In special circumstances, vehicle movement between 12 Noon & 1 PM may be approved and escorted by a Rotarian. Speed limit 5KPH (walking pace)

Pack up; 1pm to 2pm Please leave your site clean, no rubbish to be left in the carpark.

Stall Space; Traders must operate within the confines of the stall space/s purchased.

OZEE MARKETS BOOKING SYSTEM

Thank you to everyone for adjusting to our on-line Booking System - we must ALL move with the times.

CREDIT CHARGE REGULATION CHANGES

From 1st October the Reserve Bank has regulated that Credit Card charges cannot be added to transactions. There are a range of Transaction Fees behind each transaction. From 1st October RotaryOCH will absorb these charges & your booking fees will reduce accordingly from that date.

INSURANCE

To operate the Market RotaryOCH is required to have \$20 million public liability insurance & **Traders are required to have public liability & product liability insurance**. All Traders are urged to have their own insurance. Please ensure your insurance cover note is uploaded on Ozee Market & or provided to RotaryOCH by **4th October**. Blanket insurance for Traders cost RotaryOCH \$12,600 this year. We are negotiating the insurance arrangements / requirements effective from 21st November 2026. When the new Insurance arrangements are finalised Traders will be given appropriate notice, BUT costs will go up.

MARKET FEES

Once the Credit Card & Insurance issues are resolved, our Market Charges will increase. We will give two months' notice of the price increase. The current prices have been in place since 1st October 2021.

MARKETING THE MARKET

Over the past 12 months we have delivered 20,000 Market promotion flyers, in local communities. Galaxy Plants have arranged for Radio Station 3XY to broadcast from the Market on 27th September.
