MARKET TRADING HOURS 8.00 am to 1.00 pm

- Vehicle Movement restricted between 8.00 am and 12.00 noon.
- Stalls may be occupied from 6.00 am for the purpose of setting up. (Not before 6am)
- Stalls not occupied by 8.00 am may be forfeited.
- Please pack up and vacate market area before 2.00 pm.
- All rubbish and unsold goods must be taken away by stall holder and the site left clean.
- Do not dispose of rubbish in shop bins

IMPORTANT MARKET INFORMATION

CONDUCT: RotaryOCH wishes to provide a friendly, pleasant and safe environment for the public to enjoy. Stall holders are therefore required to observe acceptable standards of courtesy and behavior towards the public, other stall holders and Rotary Volunteers.

RotaryOCH reserves the right to refuse admission to, or eject any person from the market without providing any reason.

PARKING: Vehicles not parked in Stall Spaces are to be parked legally in surrounding streets or car-parks.

SITES: Sites are public car park (min 2.5 metre x 4.3 metre). Stall holders must operate within the confines of the stall space allocated. No items are to be placed in walkways. Un-authorized use of "vacant" sites is prohibited. If you wish retain your vehicle on site & trade from it, anything larger than a standard sedan will require TWO or more sites. Sites with POWER are available. An additional charge may apply.

BOOKING: Casual stalls are available for booking and are made available to the public from 6.00 am. Casual stall holders must obtain a ticket to be allocated a stall. Stalls may be re-booked for the following week at the discretion of RotaryOCH.

EXCHANGE: Tickets for pre-booked stalls must be returned to the RotaryOCH caravan (or by advice to RotaryOCH Phone M 0466 546 059) before 8.00 am on date of booking to be eligible for exchange. No refunds will be issued.

FORFEIT: Stalls not occupied by 8.00 am may be forfeited to casuals requiring stalls. However, consideration will be given to restoring the stall to the stall holder for the following week if the request is notified to the Rotary Market Leader at the market by 10.00am.

INSURANCE: All Traders must be insured for Public Liability, & Product Liability of not less than \$10,000,000 indemnity and provide a valid certificate of currency from their insurance company to RotaryOCH.

WET WEATHER PROCEDURE: The Rotary OCH Market Leader will manage the procedures.

On wet days, stall holders are still required to attend the market at the commencement time or risk forfeit of their stall. You are advised to provide your own protection against minor weather changes. In the event of constant rain or other severe conditions, a decision will be made by the RotaryOCH Market Leader, regarding cancellation of the stall holder obligation to remain at the market. The decision will be made before 10.00 am.

If weather change occurs after 10.00 am no cancellation will be made.

1. If a decision is made to continue, stall holders are requested to remain at the market.
2. In the event of cancellation, stall tickets will be exchanged for one for the following week only. Preference will be given to the same stall position where possible, however in some cases casual stallholders may be required to accept a different stall number. No cash refunds or discounts will be given.
3. After cancellation, some stall holders may wish to remain at the market. In this event they will be required to pay to re-book their stall for the following week.
4. Stall holders wishing to leave prior to the official decision (to be made by 10 am) must pay to re-book their stall for the following week.
